

SALES AGREEMENT

This puppy is in good health to the best of my knowledge. It is up to date on shots and dewormings and appears to have no signs of sickness.

HEALTH GUARANTEE

The purchaser has 72 hours to have the puppy checked by a licensed vet. Upon finding an infectious disease, the purchaser must notify breeder immediately to return the puppy for a full refund. In the instance that the purchaser wishes to keep the puppy, the purchaser will assume responsibility to pay for all medicine and necessary medical attention and treatment. Any illness or imperfection that was disclosed before purchase is not a valid reason for return, or for monetary compensation from the breeder. *Weimaraners, along with several other breeds, have a predisposition for the potential of having vaccine reactions.* Accepted vaccine protocols can be found on the Weimaraner Club of America's website at www.weimclubamerica.org. As with any breed please discuss with your veterinarian which protocol is right for your puppy. Failure to have the puppy checked within the 72 hour period, failure to contact breeder concerning illness within 72 hour period, or failure to have other animals in your home that the puppy will be exposed to checked for infectious disease will void the guarantee. A letter from purchaser's vet is required, and the breeder's vet must confirm the diagnosis. Infectious diseases do not include parasitism (worms, ear mites, fleas or Giardia, etc.). In the event the puppy has coccidia or Giardia, breeder will pay for medication to treat the puppy, but will not include vet visits or other expenses. In addition, breeder will replace puppy with one of equal value when available, or refund purchase price not including expenses incurred by purchaser if it dies within 1 year from date of purchase due to hereditary illness, and if the following conditions are met:

1. Purchaser must notify breeder immediately of any illness.
2. Purchaser must have followed advice from breeder directed from vet of breeder's choice.
3. Purchaser must allow post mortem exam by vet of breeder's choice within 24 hours of death. If hereditary illness is confirmed, breeder will take responsibility for post mortem exam; otherwise purchaser must take responsibility.

Breeder is not responsible for ANY medical, travel, upkeep or shipping costs.

Purchaser's Responsibilities: Purchaser assumes all responsibility and expenses incurred for the health, temperament, behavior, appearance and total well being of the puppy upon possession and after purchaser's veterinarian deems the puppy healthy. Breeder does not guarantee perfect confirmation, size, or temperament. If a medical condition arises that purchaser can not afford (surgery, etc.) and they consider euthanasia, breeder has first rights to take back the dog permanently and become responsible for the puppy with no monetary compensation given to the purchaser.

Each puppy is eligible for registration with the AKC. It is the purchaser's responsibility to register the puppy. Registration papers are given when the puppy is paid for in full. In no way is the breeder responsible for registration after that point.

A puppy is a lifelong commitment; my intentions are to sell a puppy to its forever home. **However if within the first six months the purchaser can no longer keep the puppy, purchaser must give notification to breeder. Breeder will gladly take puppy back as long as it is within the above mentioned time period to find a suitable home for it if the purchaser can not. No monetary compensation will be given.** No puppy is ever to be euthanized for any other reason than medical. Proof of medical condition will be asked for if euthanasia is considered.

[] When checked, this means puppy is being sold with limited registration and a spay/neuter contract. This puppy is not to be used for breeding. Any violation will result in legal action.
